#### Out with the Old ...

- Last registration for old RCVS Certificates November 2007
- Assessment infrastructure to remain in place for 5 years
- RCVS Subject Boards to continue to run the old Certificates
- Certificate sub-committee to oversee the new modular Certificates



#### In with the New ...

- Modular Certificate accreditation process now in place
- Broad range of 'C' modules
- Designated Certificates approved
- Universities can be accredited to offer both individual modules and complete Certificates
- Other providers can supply course content alone or form partnerships with Universities for assessment

### Role of the new Certificate ...

### **Education Strategy Steering Group Report**

"A framework for 2010 and beyond (2002)":

"Achievement of a Certificate, or working towards Certificate modules, should become the norm for new practitioners"

"...not seen as quasi-specialist qualifications"

"A significant proportion of CPD provision should be geared to those modules"

"The standard of the RCVS Certificate must not be lowered in the process" (that of a "competent practitioner")



## **Meeting CPD requirements**

- RCVS mandatory CPD requirement 105 hrs over three years
- Even one module (100 hrs nominal study time) per year would more than meet current requirements
- Preparedness for possible revalidation



## The purpose of CPD

- To maintain and advance professional performance
- To encourage the advancement of knowledge
- To reassure the public



## The purpose of CPD

- Improve knowledge base (propositional knowledge)
- Improve competence/ skills base
- Improve cognitive and learning skills (process knowledge)
- Encourage transformative learning

- Holistic CPD
- Learner-driven
- Work-based, experiential style
- Reflective
- Flexible
- Portable
- Encourage a true improvement in performance
