

## Application for Temporary Registration Form

### Accompanying Animals

This form is for veterinary surgeons not eligible for full registration under the Veterinary Surgeons Act 1966 who seek Temporary Registration to provide veterinary care for animals which they are accompanying for a limited period in the United Kingdom. A veterinary surgeon fully registered in the UK must undertake to ensure that the temporary registrant only practises veterinary surgery in respect of the animals in question.

**Please note: Temporary Registrants may not use the post-nominal MRCVS – they cannot sign prescriptions or certificates, or other documents that require the signature of an MRCVS.**

Please submit the temporary registration application 14 working days before the date you intend to provide services or as soon as possible.

We will acknowledge your application within 3 working days.

You will receive confirmation of your entry to the Temporary List via email within 10 working days of the RCVS receiving your completed application.

Please be advised that we can only process your application once we have received the following information:-

- Completed Temporary Registration Form
- Checklist with complete list of documentation (Please refer to the checklist)
- Payment in full
