

# **Application for Temporary Registration Form**

### **Accompanying Animals**

This form is for holders of non-European veterinary qualifications who seek temporary registration under the Veterinary Surgeons Act 1966 in order to provide veterinary care for animals which they are accompanying for a limited period in the United Kingdom. A veterinary surgeon fully registered in the UK must undertake to ensure that the temporary registrant only practises veterinary surgery in respect of the animals in question.

Please note: Temporary Registrants may not use the post-nominal MRCVS – they cannot sign prescriptions or certificates, or other documents that require the signature of an MRCVS.

Please submit the temporary registration application 14 working days before the date you intend to provide services or as soon as possible.

We will acknowledge your application within 3 working days.

You will receive confirmation of your entry to the Temporary List via email within 10 working days of the RCVS receiving your completed application.

Please be advised that we can only process your application once we have received the following information:-

- Completed Temporary Registration Form
- · Checklist with complete list of documentation (Please refer to the checklist)
- · Payment in full

5	Payment of the fee (this is refundable if the application is unsuccessful).	

If your application is approved, you may be asked to make an appointment at the RCVS offices so your original documents can be checked and verified.

#### Third party use of Register\* data

Please note the RCVS must publish your Register\* data and does so in hard copy form and the data is made available in response to enquiries. A shortened version of your Register\* data (without your full address) is available on the RCVS website. Your other personal data on this form is not published and used only for our regulatory and related purposes.

#### The Fee

Your fee will cover your temporary registration with the RCVS for 12 months from the day you are admitted to the Register.

Please note if you are choosing to register for 6 months or less then the fee due is reduced by half.
