

## Application for Temporary Registration Form

### Post-graduate education (Internships and Residencies)

This form is for veterinary surgeons not eligible for full registration under the Veterinary Surgeons Act 1966 who seek Temporary Registration to undertake an Internship or Residency in the UK.

**Temporary registration is not applicable, or intended, for roles in general practice or for other 'generalist' roles even where recruitment to such positions is difficult. Employers are expected to employ fully registered veterinary surgeons for such roles. Since Temporary Registrants may not use the post-nominal MRCVS, they cannot sign prescriptions or certificates or any other documents that require the signature of an MRCVS.**

***Please note: Temporary Registrants may not use the post-nominal MRCVS – they cannot sign prescriptions or certificates, or other documents that require the signature of an MRCVS.***

**Applicants are asked to submit their application and supporting documents at least 12 weeks ahead of the proposed start date as these applications are considered by the Registration Committee of the College.**

We will acknowledge your application within 3 working days.

Please be advised that we can only process your application once we have received the following information:-

- Completed Temporary (Restricted) Registration Form
- Checklist with complete list of documentation (Please refer to the checklist)
- Payment in full

We will acknowledge your application within three working days of receiving your completed application form and you will be notified of the outcome within five working days of the Committee making its decision. If your application is approved, you will be sent your certificate ten working days before your registration commences.

Please include the period Temporary Registration is required (please note Temporary Registration can only be granted for a maximum of five years per application).</p> <p><i>*Evidence should include full details/screenshots of advertisements placed. Please include as much detail as possible. For example, evidence that the advertisement was appropriate for the role. Why was this particular form of advertisement chosen, and was it advertised in the right places and for long enough. Evidence should also include a list of MRCVS eligible candidates [without personal data] and why they were deemed not suitable for the role.</i></p>
