


Welcome to RCVS Facts 2023.

Figure 1. Breakdown of members by category of registerable qualification






Figure 2. Breakdown of principal RCVS membership categories




Figure 4. UK-practising members by stated ethnic group





Figure 5. Registered veterinary nurses by age and gender





Figure 7. Numbers of practising veterinary surgeons / registered veterinary nurses in the UK













Figure 13 Number of concerns raised about veterinary surgeons and veterinary nurses 1 April 2022 to 31 Mar 2023


